## LEGAL NOTICE NO. 22 OF 2018

**Lesotho Communications Authority (Administrative)  
(Amendment) Rules, 2018**

Pursuant to section 5(1)(c) of the Communications Act, 2012<sup>1</sup>

**LESOTHO COMMUNICATIONS AUTHORITY**

Make the following rules -

**Citation and commencement**

1. These rules may be cited as Lesotho Communications Authority (Administrative) (Amendment) Rules, 2018 and shall come into operation on the date of publication in the Gazette.

**Amendment of rules**

2. The Lesotho Communications Authority (Administrative) Rules, 2016<sup>2</sup> (hereby referred to as the Rules) are amended as follows:

**Amendment of rule 3(10)(b)**

3. Rule 3(10)(b) is amended by inserting the words “and postal” between the words “broadcasting” and “licensees”.

**Amendment of rule 4**

4. Rule 4 is amended by adding the following sub-rules:

- “(3) The licence conditions for postal licensees may vary depending on the type of licence and activities performed in Lesotho.
- (4) The licence for global and international postal operators may be granted to their legal representative for operations in Lesotho.
- (5) Representative of global and international operators shall report separately about the activities performed on behalf of those global and international postal operators.”

**Amendment of rule 6**

5. Rule 6 is amended by deleting rule 6(2)(a) and substituting the following:

- “2. In the case of individual licence -
- (a) the licensee shall submit a renewal application to the Authority not less than two years prior to the expiry of the term of the licence justifying that renewal; and
  - (b) the submission of renewal application for postal licence shall be one year prior to the expiry of the licence.”

**Amendment of rule 28**

Rule 28(2) is amended by adding the following in their alphabetical order -

- “(f) counters at postal offices and postal agencies;
- (g) volumes in transport, and
- (h) P.O. Boxes.”

**Amendment of rule 37**

7. Rule 37 is amended by adding the following:

- “(2) A licensed operator who does not have an office in Lesotho shall be represented by a licensed operator for CEP in Lesotho;
- (3) An operator who intends to change a representative shall seek approval of the Authority before effecting that change;
- (4) The representative licensee shall report separately on activities performed for other licensees.”
